

TERMS AND CONDITIONS OF TRADING

- ___ A Payment for all fees should be in Australian Dollars by cash, credit card, direct deposit or cheque made payable to JMC Academy.
- ___ B Upon payment of the JMC Academy Enrolment Fee and appropriate tuition fee, the student's place will be secured in the course. This is subject to the student abiding to payment conditions outlined below.
- ___ C Fees for courses must be paid in full, 4 weeks prior to the scheduled course (semester) commencement with the JMC Academy.
- ___ D All semester fees must be paid prior to commencement with the JMC Academy.
- ___ E If a student fails to meet the periodic payment schedule, JMC Academy reserves the right to suspend the use of facilities and tuition pending full payment of the outstanding tuition fees.
- ___ F Course fees are refunded in full if a visa application is rejected providing documentary evidence from the relevant Australian government department is submitted. JMC Academy reserves the right to retain the Enrolment fee of \$150.00.
- ___ G Withdrawal or deferment after commencement will result in no refund of the relevant semester's fees, unless special circumstances apply. Enrolment fees will not be refundable.
- ___ H Course fees are not transferable between JMC Academy courses or between JMC Academy and other institutions.
- ___ I In the event of JMC Academy cancelling a course, all fees paid in advance will be refunded, from the date of cancellation.
- ___ J Students are required to abide by the rules and policies and Terms and Condition of Entry set by the Academy. If a student's conduct is deemed unsuitable, JMC Academy reserves the right to expel the student. All fees are due at the time of expulsion.
- ___ K JMC Academy reserves the right to update, modify or make appropriate changes to the curriculum and/or course schedule.
- ___ L The student acknowledges that during his/her use of the facility (s), he/she is responsible for ensuring no equipment in the studio is damaged as a direct result of a failure on his/her part to exercise reasonable care in the use of studio equipment. In the event that the equipment in the studio is damaged or stolen during the student's use of the studio, the student agrees to pay within (30) days, all costs relevant to replacing or repairing such equipment.
- ___ M Any course cancellations made by students are accepted by JMC Academy in writing only. Non-attendance of classes does not constitute cancellation of the course. All course costs are still payable to JMC Academy in the event of a student deferring or cancelling his/her enrolment.
- ___ N Should there be any default in the above payment terms, all monies owing to JMC Academy shall become immediately due and payable. Students who default will be excluded from the class.
- ___ O JMC Academy reserves the right to charge an Administration Fee of \$25 plus interest at 5% per month on default of agreed payment terms, such interest to be calculated on all monies and costs due or overdue up to the date of payment. This could result in a default being put against the student's credit rating.
- ___ P All expenses, costs or disbursements incurred in recovering any outstanding monies including debt collection fees, solicitor's fees and all legal costs will be paid by the student.
- ___ Q If the client is a trustee, the directors warrant that they have the authority and power to enter into this agreement and personally guarantee the performance of all of the trusts obligations under this agreement.
- ___ R The student acknowledges that JMC Academy is entitled to presume that any person purporting to have the authority to bind the student to a contract for the supply of services from JMC Academy has the authority they claim.
- ___ S These Terms and Conditions of Trading are additional to any other terms communicated in respect of the sale and supply of services and where they are in conflict, these Terms and Conditions of Trading shall prevail.
- ___ T This agreement does not remove the right to take further action under Australia's consumer protection laws. A dispute or action in relation to these Terms and Conditions of Trading shall be subject to the absolute jurisdiction of the laws in the state that the contract was signed. The student is able to pursue other legal remedies.
- ___ U These Terms and Conditions of Trading shall be binding upon the student its successors, executors, administrators and permitted assigns and shall inure to the benefit of JMC Academy, its successors and assigns.
- ___ V Students MUST attend 80% of all classes to pass. Failure to attend an exam or failure of an exam due to an attendance of less than 80% results in a re-examination fee. Failure of a unit will require a repeat, additional cost to be incurred by the student. Certification will be delayed.
- ___ W JMC Academy reserves the right to utilise student works for Marketing & Promotional purposes only.
- ___ X The student is required to inform JMC Academy immediately in writing of any change to address, email or telephone details. JMC Academy will not be held responsible to communications not received due a student's failure to update his or her contact details with Administration.
