1. PURPOSE

JMC Academy acknowledges the diversity of its student body and the full range of its students' capacities and capabilities and is committed to ensuring its students are provided with the support and resources required to assist them to be successful in their studies.

4. POLICY

4.1. Support services.

Supporting students to attain their education aspirations requires a multi-faced approach that includes providing inclusive and safe campuses. In addition to facilitating a welcoming environment, JMC Academy proactively offers students access to academic and non-academic support services, which include but are not limited to:

- Library Services,
- Academic Support,
- Student Wellbeing Support,
- Counsellors,
- Learning Support, and
- Academic Skills Workshops.

4.2. Information provided to students.

JMC Academy publishes information regarding the available support for students on its website, handbooks, and throughout its Learning Management System (LMS). This information is supplemented by other types of support available in the community, including financial management support.

- 4.3. Monitoring student success.
 - 4.3.1.JMC Academy actively monitors student engagement to identify students who may be "at risk" of not successfully completing their units and implements appropriate interventions involving academic and/or learning support officers.
 - 4.3.2.JMC Academy identifies students in need of targeted individual literacy, numeracy and other academic support requirements and communicates to them the support services available to assist them in successfully completing their units.
 - 4.3.3.JMC Academy monitors "at risk" students' progression to ensure they are meeting progression rules.



- 4.3.4.JMC Academy, in relation to students who have been identified as "at risk" of not successfully completing their units of study, ensures that additional support is available to assist those students with overcoming these issues.
- 4.3.5. Education Services provides reports to the appropriate governing bodies regarding the success of its different student cohorts, including those categorised as "at risk".

4.4. Support plans

JMC Academy proactively offers academic adjustment arrangements to students who have reported/disclosed non-academic issues that put them at risk of not successfully completing their studies.
